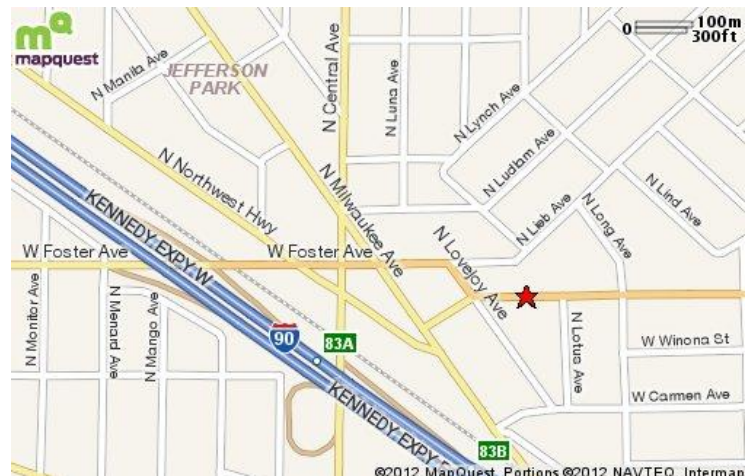
SCHEDULE
